

Terms & Conditions – Shaves Paint + Décor Dulux Competition

1. Competition Overview

- 1.1 The Shaves Paint + Decor Dulux Bakkie Giveaway (“the Competition”) is run by Shaves Industrials (Pty) Ltd (“the Promoter”).
- 1.2 The Competition will run from **18 August 2025** to **10 December 2025**.
- 1.3 Customers who purchase any of the **qualifying Dulux products** listed in Clause 2.1 during the competition period will receive entries into the monthly draw.

2. How to Enter

- 2.1 Qualifying Products
 - a. Dulux Trade Weathershield
 - b. Dulux Trade 100 Low Sheen
 - c. Dulux Dampshield
 - d. Dulux Trade Alkali Resistant Primer
 - e. Dulux Trade 70 Mid Sheen
 - f. Dulux 65 Matt
 - g. Dulux Luxurious Silk
 - h. Dulux Weatherguard Ultrasmooth
- 2.2 Entry Allocation
 1. 1 entry for every 2x5L purchased
 2. 2 entries for every 1x20L purchased
- 2.3 Entries are calculated based on the quantity purchased, as per sales data generated from the promoter’s point-of-sale system.
- 2.4 **Entries do not carry over from one month to the next.** Purchases must be made in the relevant calendar month to qualify for that month’s draw. Customers must make new qualifying purchases in subsequent months to qualify for those monthly draws.
- 2.5 **Monthly draw cut-off and announcement dates:**
 1. **Draw 1:** Purchases from 18 Aug – 18 Sept 2025 (cut-off 5:00pm) – Winners announced 22 Sept 2025.
 2. **Draw 2:** Purchases from 19 Sept – 18 Oct 2025 (cut-off 1:00pm) – Winners announced 22 Oct 2025.
 3. **Draw 3:** Purchases from 19 Oct – 18 Nov 2025 (cut-off 5:00pm) – Winners announced 21 Nov 2025.
 4. **Draw 4:** Purchases from 19 Nov – 6 Dec 2025 (cut-off 5:00pm) – Winners announced 8 Dec 2025.
- 2.6 **Online Orders:** Qualifying purchases may be made in-store or via the Shaves online store (launching October 2025).
 1. Online purchases will only qualify if placed for **Click & Collect** at participating Kwazulu-Natal or Johannesburg (Sandton) stores.

2. Online purchases for nationwide delivery will not qualify for entries, as this competition is restricted to customers in the Kwazulu-Natal and Sandton (JHB) regions where Shaves Paint + Decor stores are located.
- 2.7 **No late entries will be accepted.**

3. Monthly Draws

- 3.1 Two (2) winners will be selected each month via a random draw from all valid entries for that month.
- 3.2 Monthly winners will each receive a smaller prize, as determined by the Promoter.
- 3.3 Monthly winners will also qualify for entry into the **Main Draw** for the grand prize of a Mahindra Bolero.

4. Main Draw

- 4.1 All monthly winners will be invited to participate in the Main Draw event.
- 4.2 The Main Draw will take place on **10 December 2025** at Shaves Umhlanga.
- 4.3 At the event, each monthly winner will select one (1) key.
 1. Keys will be tested in the Mahindra Bolero's driver-side door lock.
 2. Only one (1) key will successfully unlock the vehicle.
- 4.4 The winner whose key unlocks the vehicle will be the grand prize winner.
- 4.5 If a monthly winner cannot attend the Main Draw in person, they may nominate a representative in writing.
- 4.6 **Johannesburg Monthly Winner Travel Provision:** If a monthly winner is based in Johannesburg, Shaves will pay for a return flight to and from Durban. The winner will be collected from the airport in Durban, transported to the event, and returned to the airport after the event. In addition, the winner will receive **R400 cash** for a meal and drink. No other expenses will be covered by Shaves. If the winner wishes to travel to Durban earlier or return later than the event date, they must make and cover their own arrangements.

5. Exclusions & Eligibility

- 5.1 The Competition is open to all customers of Shaves Paint + Decor, except employees, directors, and agents of the Promoter, as well as their immediate families.
- 5.2 Participants must be 18 years or older to claim any prize.
- 5.3 30 Day Account holders must be within their credit terms at the time of any draw to remain eligible. Overdue accounts will result in forfeiture of entries.
- 5.4 Only paint purchased on **invoices issued directly by Shaves Paint + Decor** will qualify for entries. Purchases invoiced through any other channel will not be eligible.
- 5.5 Participants who win in a **monthly draw** will not be eligible to win again in subsequent monthly draws of this same competition.
- 5.6 The winner of the **Grand Prize (Mahindra Bolero)** will be subject to an exclusion period of **18 months** from the date of winning and will not be eligible to participate in or win the grand prize of the next Shaves Paint + Decor competition.

6. Grand Prize - Vehicle Details

- 6.1 The grand prize is a **brand new Mahindra Bolero**, currently registered to Shaves Industrials (Pty) Ltd.
- 6.2 The vehicle may have some mileage due to movement between Shaves stores during the competition period.
- 6.3 Shaves Industrials (Pty) Ltd will pay for the transfer of the vehicle into the winner's personal name (if an individual) or the company's registered name (if a business) within **one (1) week of the Final Draw (by 17 December 2025)**.
- 6.4 From the date of transfer, the new owner will be responsible for all costs and liabilities associated with the vehicle, including insurance, licensing, and maintenance.
- 6.5 The prize is not transferable, exchangeable, or redeemable for cash.

7. Vehicle Ownership Transfer

- 7.1 If the winner is a sole owner of a business registered with Shaves, the vehicle will be transferred into their personal name.
- 7.2 If the winner is a company with multiple owners, the vehicle will be transferred into the company's registered name.
- 7.3 If the winner is a private (retail) customer, the vehicle will be transferred into their personal name.

8. Vehicle Collection:

- 8.1 Physical collection of the vehicle will only take place once the transfer of ownership has been completed.
- 8.2 Collection must occur within **one (1) week** of the transfer being finalised.

- 8.4 If the winner is based in Johannesburg (or outside KwaZulu-Natal), Shaves will not cover the cost of delivery of the vehicle to Johannesburg or elsewhere. The winner is responsible for arranging collection or transport of the vehicle at their own cost.

9. General Conditions

- 9.1 The Promoter's decision regarding winners and prize allocation is final and binding, and no correspondence will be entered into.
- 9.2 The Promoter reserves the right to verify the eligibility of all entries and to request proof of purchase.
- 9.3 Prizes may not be substituted except at the Promoter's discretion in the event of circumstances beyond their control.
- 9.4 The Promoter reserves the right to amend these terms and conditions at any time without prior notice.

10. Publicity

- 10.1 By entering the Competition, participants consent to their name, photograph, and likeness being used for promotional purposes in any media without additional compensation, except where prohibited by law.

11. POPIA Compliance (Protection of Personal Information Act)

- 11.1 By entering this Competition, participants acknowledge and consent to the collection, processing, and storage of their personal information by the Promoter for the purposes of administering the Competition and awarding prizes.
- 11.2 All personal information will be processed in accordance with the Protection of Personal Information Act, 4 of 2013 ("POPIA").
- 11.3 The Promoter will not share personal information with third parties except as necessary to administer the Competition, deliver prizes, or as required by law.
- 11.4 Participants have the right to request access to, correction of, or deletion of their personal information by contacting the Promoter in writing.

12. Liability

- 12.1 The Promoter will not be held liable for any loss, damage, injury, or claim arising from participation in this Competition or the use of any prize.
- 12.2 The winner assumes all risks and responsibilities associated with the use of the vehicle after the date of transfer.
